BETTING, GAMING & LOTTERIES COMMISSION **CHANGES IN LICENSING DEADLINES AND FEES**

On June 22, 2010 the BGLA was amended to require Gaming Machine licences issued after June 22, 2010 & Prescribed Premises Licences to expire on March 31st of each year. Expiry dates, Levies and Fees for Betting Office Licences, Betting Agent Licences and Bookmakers Permit remain the same. The Act was further amended for the adjustment of the requisite fees as outlined below.

Take Note:

1. Pay all Levies at your nearest Inland Revenue Office or Tax Collectorate in your Parish. The **ORIGINAL** receipts **MUST** be submitted with all applications.
2. Fees stated above exclude all outstanding fees for existing unlicensed gaming machines.
3. Gaming Lounge Licensees pay CHASE Fund Contribution at any branch of the National Commercial Bank, Account # 301064179 -Half Way Tree Branch.
4. All applications for renewal of gaming machine licences must be submitted no less than twenty-one (21) days prior to the expiration of current licence.
5. Sports Betting Licensees pay CHASE Fund Contribution at any branch of the National Commercial Bank, Account # 301253702 -Half Way Tree Branch.
6. Applications for renewal of Betting Sector Licences should be submitted no less than 60 days ahead of expiration of current licence.
