



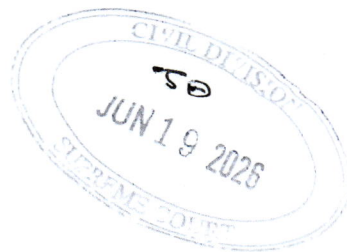

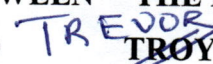

UPON THE HEARING OF THE FIXED DATE CLAIM FORM filed by the Director of Public Prosecutions and dated June 18, 2026 and coming up for hearing this day and upon hearing Counsel for the Applicant, Ashtelle Steele and Malike Kellier as instructed by the Office of the Director of Public Prosecutions.

IT IS HEREBY ORDERED THAT:

1. By virtue of section 14(2) and 14 (4) of the Terrorism Prevention Act and its amendments it is declared that **Trevor W. Forrest a.k.a Shaikh Abdullah Faisal a.k.a Shaikh Faisal** is a listed entity for the purposes of the Terrorism Prevention Act and the amendments thereto.
2. In accordance with section 6 (1) of the **Terrorism Prevention Act**, no person in Jamaica or no Jamaican in or outside of Jamaica shall knowingly:
 - a. deal directly or indirectly with any property that is owned or controlled by or on behalf of the above listed entity;
 - b. enter into or facilitate, directly or indirectly, any transactions in respect of that property that is owned or controlled by on behalf of the above-mentioned listed entity;
 - c. provide any financial or related services in respect of that property that is owned or controlled by or on behalf of the above-mentioned listed entity; or
 - d. Convert any property owned or controlled by or on behalf of the below mentioned entities or take any steps to conceal or disguise that property is owned or controlled by or on behalf of the above-mentioned listed entity.

3. The Applicant's attorney is to prepare, file and serve a copy of this Order on all relevant or competent authorities and financial institutions.
